Expansion and Training Opportunities

It is to the credit of the 2005 Officers, Expansion Committee Chairs, Bambi Magaw and Marc Sevigny, and the entire organizational membership that MADRP has remained committed to its five year strategic plan and organizational objectives to: make MADRP a truly statewide organization and deliver relevant, high quality programs and training.

Making MADRP a statewide organization could not have been achieved if the leadership had failed to designate financial and human resources to the task. In making expansion and training opportunities happen for mediators in the northern and down east portions of the state, those who crafted the 2002 - 2005 strategic plan and related objectives, must have understood that making change happen would be a long process and would place additional demands on the MADRP leadership. How has statewide expansion and training promoted? MADRP's Expansion Committee"s capacity to work cooperatively with the Court Alternative Dispute Resolution Service (CADRES) to advance mediation and the professionalism of the membership of both organizations has been a success. Mediators, facilitators and arbitrators who hold membership in one or both organizations, while they are aware of their responsibilities to organizational membership, are also able to meet occasionally for training and to share their

common concerns about ADR.

A recent example of MADRP's Expansion Committee activities took place on June 13, 2005 in Bangor. Following the CADRES Bangor Regional Meeting, mediators from Aroostook County presented a provocative workshop, Maintaining Neutrality When Mediating in Small Town Maine. MADRP and CADRES coordinated meetings for the same day, CADRES Regional Meeting in the morning, the workshop sponsored by MADRP Expansion Committee in the afternoon. A combined group of twenty, with membership from Bangor, north, down east and guests from other parts of the state, gathered for the workshop. This is the third such coordinated program which has been jointly arranged by the two organizations in the last two years.

MADRP and CADRES members have benefited from expansion activities and the delivery of high quality training programs. As Susanna Liller said in June MADRP Bulletin, you will be hearing more on the topic!


