## More from our Mediation and Meditation Conference

"Buddhist ways of Peace Building"

In Tibetan Buddhism, peace is not merely the absence of conflict but a particular state of mind and a ground of social behavior in and of itself. Social peace depends upon the cultivation of inner peace; as individuals rise in personal serenity and equanimity, they spread this insight into their society through their actions. When serenity, mindfulness and centeredness exist, conflict and negative emotions cannot be present. In general the principle is that the problems of conflict cannot be solved at the level of the problems themselves, that peace and patience are the solutions. With this in mind, Geshe Lobzang Tsetan, a highranking monk of the Geluk-pa sect (same sect as the Dalai Lama) teaches meditation and other techniques for cultivating the compassion and patience that allow Tibetans to be free of anger toward the Chinese while still seeking freedom for their homeland. Geshe Tsetan offered MADRP practical advice on how to include Buddhist teachings into a mediation practice. Dana Sawyer

Cushman D. Anthony began family law mediation in Portland in 1980, and has done it exclusively since 1995. As lawyer he found mediation to be "the better way", more in keeping with his personality. He is a long-time CADRES mediator, and qualified as a Practitioner member of the Academy of Family Mediation and later of the ACR Family Mediation Section. Cush was in the Legislature when it established the Commission to Study the Future of Maine's Courts and became a member of that group. Subsequently he was appointed as Chair of the ADR Planning and Implementation Committee to establish greater use of ADR and developed the Superior Court ADR, Rule 16B. He has been actively involved in the use of Restorative Justice approaches to criminal offenses, and the development of victimoffender conferencing in Portland and continues this work by volunteering at the Community Mediation Center. He was selected as the country's Volunteer Mediator of the Year by the National Association for Community Mediation.

Cush describes himself as a chronic do-gooder, serving on many boards and working with social change organizations. He recently announced that he intends to retire and close his office at the end of this calendar year. He will work for five months in Washington for the Friends Committee on National Legislation, a Quaker lobby group and then hopes to work at a slower pace, get a chance to enjoy his family more, continue with volunteer and some paid mediation work, and travel. He lives in Falmouth with his wife Karen and their four children are spread over the United States from Vermont to Hawaii.
