# Grant-sponsored Mediator assists parties for Maine Human Rights Commission

Rebekah Smith, a Maine lawyer and mediator, has been awarded a Flom Incubator Grant from the Skadden Fellowship Foundation to conduct mediations for low-income and unrepresented parties involved in actions before the Maine Human Rights Commission (Commission). Ms. Smith, who conducted a two-year Skadden Fellowship beginning in 2000 representing low-income families in impact litigation and in administrative and legislative arenas, has a practice focus on mediation, arbitration and administrative hearing officer work. She is also a Policy Fellow at the Margaret Chase Smith Policy Center at the University of Maine, which is administering the grant. When the Flom Incubator Grants were made available to former Skadden Fellows last year, Ms. Smith submitted a proposal to increase mediation services to individuals who might not otherwise be able to utilize such options.

Amy Sneirson, Executive Director of the Commission, states that "because the goal of the Commission is ultimately to resolve disputes, we place a strong emphasis on conciliation and mediation processes to help parties reach resolution. We are thrilled to work with Rebekah Smith as she implements this grant, which will support our efforts to expand the possibilities for resolution at all stages of Commission proceedings." In conjunction with those efforts, the Commission recently hired former Portland mayor and councilor **Jill Duson** as Compliance Manager. The compliance manager is responsible for oversight of all resolution processes and undertakes the Commission's public education outreach.

The Commission's charge is to enforce Maine's anti-discrimination laws, primarily the Maine Human Rights Act. Last year, 764 charges of discrimination were filed before the Commission. Over three-quarters of the claims were employment-based with housing and public accommodation cases comprising most of the balance. Approximately two-thirds were claims of discrimination were based on disability, sex, and whistle-blower retaliation. Other categories of alleged discrimination included race, sexual orientation, age and national origin. Although legal services organizations do represent parties before the Commission, approximately half of all parties are unrepresented.

With the Flom Incubator Grant, Ms. Smith will provide mediation services in approximately forty Commission cases involving unrepresented and low-income litigants. In particular, cases that are in the process of investigation and have not yet received a ruling by the Commission will be selected for mediation. **David Webbert**, president of the Maine Employment Lawyers Association, frequently represents people who bring discrimination claims before the Commission. Mr. Webbert said that "this expansion of options for early ADR with professional mediators will promote the speedy and just resolution of these very important cases." **Stephen Langsdorf**, partner at Preti Flaherty who concentrates on the representation of businesses and municipalities, supported the Commission's mediation program because "early mediation is critical to the successful operation of the Commission process." Mr. Langsdorf suggested that a mediation option within the first six months of filing could decrease the backlog of cases such that the Commission process would not be simply a delay before filing suit but would fulfill its function of resolving cases.

# Coming from away...

MAM's conference committee reports to the BULLETIN that it is proud and pleased so many prominent Maine-based professionals agreed to present at the MAM spring conference on Thursday, May 10. Equally exciting is that two New Hampshire-based, long time trainers and practitioners will visit that day. To begin their introduction to Maine folks, below is just a short history of the work they have done or continue to do that makes us greatly honored to host them as afternoon presenters at the conference.

Melinda Gehris is a founding partner in Hess Gehris Solutions. She focuses her practice on dispute resolution, training and coaching. Her interest in mediation began early and she describes herself as a conciliator at heart. Ms. Gehris has been mediating since 1994 and regularly mediates and arbitrates for private parties. She also mediates for the New Hampshire Probate and Superior Courts, the federal court system, the Equal Employment Opportunity Commission and the New Hampshire Human Rights Commission. Ms. Gehris is an experienced trainer, developing and leading programs in dispute resolution from basic mediation skills to advanced, and specialized dispute resolution training and negotiation. She has also written and published several articles on dispute resolution topics and been named to Woodward and White's Best Lawyers in America since 2007 in dispute resolution. Ms. Gehris has been appointed to several New Hampshire court committees focusing on dispute resolution matters. She is past-president of the New Hampshire Association for Conflict Resolution, and a member of the New Hampshire Bar Association's Dispute Resolution Committee. Ms. Gehris teaches alternative dispute resolution courses at the University of New Hampshire School of Law. She received a J.D. from Northeastern University School of Law and also earned a Certificate in Dispute Resolution from the University of Massachusetts.

Ericka B. Gray is the founder of Disput*Ed*, providing a full range of assessment, consulting, intervention, training, and coaching services designed to prevent, manage, and resolve conflict and difficult issues. She has been a professional mediator since 1985 and has served as the founding executive director of the Middlesex Multi-Door Courthouse, director of Professional Services, senior mediator and regional training coordinator for the Boston office of JAMS (formerly Judicial Arbitration and Mediation Services)and also previously for Endispute. Ms. Gray has taught mediation at Boston College Law School since 1992 and at Suffolk University Law School in Boston since 2000. She also teaches mediation and other conflict resolution courses at Northwestern University in Chicago. Ms. Gray previously served as the executive director of the Academy of Family Mediators, was on the board of directors of the New England chapter of the Association for Conflict Resolution (ACR) and has served on its leadership council for the workplace section. She was the first to hold advanced practitioner status in both the workplace and family sections of ACR. Ms. Gray previously served on the Massachusetts Supreme Judicial Court's standing committee on dispute resolution and is actively involved in a variety of dispute resolution legislative efforts.
