#### Message from the Susanna- the Pres!

## Highlights from Peace Building for Your Practice

I think this spring conference was one of our best.

I mentioned in a previous column how I think it's difficult for neutral mediators and facilitators to find a way to express concern and outrage about the state of our world today, specifically about the wars in Iraq, Afghanistan and in the Middle East. My facilitation experience at the Seeds of Peace, has taught me the importance of a "third neutral" party to work with both sides and I know my ability to act as a neutral gives me that opportunity. But it can also be frustrating to be "in the middle." Therefore I was greatly looking forward to hearing and understanding how a Tibetan Buddhist Monk would approach this dilemma, particularly knowing of their very non-violent response to the Chinese takeover of Tibet. Geshe Lobzang Tsetan told us that before we do anything else we need to cultivate peace inside of us. Dana Sawyer, Associate Professor of Religion and Philosophy at the Maine College of Art and Bangor Theological Seminary, reinforced this thought when he said that "conflict is what you get when peace is absent." He stressed that we shouldn't try to change others, but rather, work on changing ourselves. Olivia Stokes Dreier, Associate Director of the Karuna Center of Peacebuilding in Amherst, shared her observations that when we allow others to tell their stories and to grieve, a new understanding emerges confirming that suffering is something we all hold in common. Someone in Bosnia remarked to Olivia, "We are all in one big pot of suffering." All the speakers talked about the importance of compassion and of first having compassion for ourselves.

During the day, I heard that I can have more influence working on becoming a more compassionate person than I had previously thought - that maybe the influence wasn't visible, but it could be just as effective my friend who holds her peace sign on a bridge over the Kennebec River. Olivia told us about the Zulu word, "ubuntu". She said it was difficult to translate into English, but means "collective personhood", that "a human being is a human being through other human beings" and that "my Self is inextricably caught up with your Self".

I came away from the day understanding once again that we are all somehow connected, and the more I cultivate my inner peace and compassion the more that can effect others in a positive way. It was a good day for me and it was made all the more special by sharing it with the MADRP community- one of my very favorite groups of people.

## **Facilitator Workshop**

The first MADRP workshop for facilitators was offered at the May conference by Laura Moorehead, an independent consultant to organizations. Laura partners with organizations to create strategies, education, and coaching to formal and informal leaders and teams. She is also a professor at Bentley College, where she teaches intercultural studies.

The workshop was attended by a dozen facilitators who engaged in a lively discussion of methods for managing groups and ways to incorporate peace-making into our practice.

MADRP will continue to offer workshops on subjects of interest to facilitators at each future conference, as part of the on-going initiative of recruiting facilitator members and serving their interests.

Thanks again to Jeff Croft and Elaine Walsh for putting together such a meaningful day for making it all happen.
